DECISION

SUBJECT: Approval of Company Activity "LIBEROPOULOS SERVICES AND WORKS LIMITED LIABILITY COMPANY", with alternate titles "LiberAssurances" or "LiberAssurance" or "LIBERO HELLENIC REGISTER" as accredited / notified organization of compliance assessment.

'Taking into consideration:

1. The provisions of Article 90 of the "Code of Legislation for the Government and Government Body", ratified by Article 1 of Presidential Decree no. 63/2005 (A '98)' Codification of Government Legislation by Government Bodies'.
2. P.D. 123/2016 (A'208) "Reconstruction and Renaming of Ministries", according to which the Ministry of Economy, Development and Tourism is renamed to Ministry of Economy and Development.

WE DECIDE

Article 1

Approval of Activity

The activity of the Conformity Assessment Body "LIBEROPOULOS SERVICES AND WORKS LIMITED LIABILITY COMPANY", with alternative distinctive titles "Liberoservices" or "LiberAssurance" or "LIBERO HELLENIC REGISTER", Tax Number: 997621522, with registered office at 210, Laskaridou Street, 176 75 Kallithea Attica (and branch: 2, Efploias Street, 18537 PIRAEUS), in the fields of Union harmonization legislation, as defined in Article 2.

Said Conformity Assessment Body shall be notified to the European Commission and to the other Member States through the NANDO system for the fields of Union harmonization legislation referred to in Article 2.

The organization "LIBEROPOULOS SERVICES AND WORKS LIMITED LIABILITY COMPANY" may carry out activities of a notified body only if no objection has been lodged by the Commission and the other Member States within two weeks of its notification to the NANDO system of the E.U.

Article 3

Obligations of the Conformity Assessment Body

The conformity assessment body "LIBEROPOULOS SERVICES AND WORKS LIMITED LIABILITY COMPANY" must:

1. Continuously comply, throughout the period of validity of this Decision, with the requirements set by Joint Ministerial Decision No. F.01.2/DDP 1828/31.5.2016 [Government Gazette 1897 / B / 27-6-2016] and in particular Articles 5, 6 and 7 thereof.
2. Fulfil the obligations set forth by the Joint Ministerial Decision No. F.01.2/DDP 1828/31.5.2016 [Government Gazette 1897 / B / 27-6-2016].
3. Carry out the activities and fulfil the obligations arising from the fields of union harmonization legislation and the fields of national technical industrial legislation referred to in Article 2 and for which it has been authorized to operate.
4. Notify the competent authority issuing this Decision without delay of any significant change affecting the terms under which this decision was issued and / or the requirements of Joint Ministerial Decision No. F.01.2/DDP 1828/31.5.2016 [Government Gazette 1897 / B / 27-6-2016].
5. Be placed under the supervision of the ESYD legal entity in private law, as provided for by Joint Ministerial Decision No. F.01.2/DDP 1828/31.5.2016 [Government Gazette 1897 / B / 27-6-2016].

In addition, it undertakes, by a deadline of 31-12-2019, the obligation to register, either directly or through designated representatives, with the relevant coordination group of notified bodies for Directive 2013/53 / EU.

Article 4

Changes to approval and notification - Penalties

If it is found that the Conformity Assessment Body does not meet the conditions of this Decision or the requirements of Joint Ministerial Decision No. F.01.2/DDP

1828/31.5.2016 [Government Gazette 1897 / B / 27-6-2016], or proceeds to actions in breach of said Joint Ministerial Decision, or fails to fulfil its obligations, same shall be subject to the penalties provided for in Article 19 of Joint Ministerial Decision No. F.01.2/DDP 1828/31.5.2016 [Government Gazette 1897 / B / 27-6-2016].

Article 5

Period of validity

This Decision shall apply until 11-09-2023.
