Recreational Craft Directive

The new recreational craft directive, 2013/53/EU known as RCD II has become mandatory as of 18th of January 2017.

The directive states that boats of hull length from 2.5 to 24m, personal watercraft, their components and engines, must bear a CE marking symbol that demonstrates compliance with the requirements of the directive.

The following products fall within the scope of the directive:

- recreational craft
- personal watercraft
- marine components that are to be fitted on recreational craft
- marine engines that are to be fitted on recreational craft

The CE Marking for recreational crafts and their components demonstrates high product quality and safety for both consumers and the environment throughout the entire lifecycle of the vessels.

- Conformity assessment for engines' exhaust and noise emissions
- Certification according the new directive 2013/53/EU, required for CE marking of the relevant products

Certification process

The certification process is as follows:

- Submission of certification application, including technical documentation
- Review of the technical file by LHR
- Inspection and tests carried out by LHR inspectors where required for the products under assessment in order to verify that the essential requirements are being met
- Issuance of certificate
